#### **GUIDE TO INTERNATIONAL OCS PROGRAMS**

The following document outlines the basic program elements for each Operation Clean Sweep® (OCS) program. OCS is an industry-led program that supports companies in their goal to achieve zero resin loss in operations.

Established in 1991 by Plastics Industry Association (PLASTICS), OCS has been administered in partnership by PLASTICS and American Chemistry Council's (ACC) Plastics Division since 2004. International expansion of OCS began in 2010 and continues to expand today, with membership reaching more than 5,000 companies worldwide.

In total, there are more than 15 active OCS programs operating in more than 65 countries around the globe. Each program enables companies to commit to the core OCS Pledge and also brings unique qualities specific to their geographic and cultural contexts. The Guide to International OCS Programs is intended to provide

an overview of each individual OCS program and information on program requirements, eligibility criteria, and contact information to learn more about each.

To become an OCS member, contact the OCS program directly in the country or region that your organization has plastic resin handling operations. OCS resources are available from each International OCS Program in English. Some resources, such as the OCS Manual, are available in additional languages, including Spanish, Dutch, French, Italian, Polish, Turkish, Danish, and Portuguese. Programs with resources in languages other than English are outlined under each program's individual page.

### **OCS Pledge**

- 1. Commit to making zero plastic resin loss a priority and sign the OCS Pledge.
- 2. Assess your company's situation and needs.
- 3. Make necessary upgrades in facilities and equipment as appropriate.
- 4. Raise employee awareness and create accountability.
- 5. Follow up and enforce procedures, including routine inspections and continuous improvement.

- List of procedures, instructions, checklists, and other documents created exclusively for the correct implementation of the program, or those modified documents in which sections on the program were added.

**OCS Eligibility:** Trade association membership is not required. An organization must physically handle plastic resin to join; current participation across the supply chain is reflected in the table below.

The 2030 Vision outlined OCS's four strategic objectives: 1) strengthen program rigor and transparency, 2) create and share knowledge, 3) improve recognition and communication, and 4) expand scope.

### **Glossary**

External inspection - An inspection that is conducted by an audit service provider, consultant, or certification body.

**Facility** – One or more plastic resin handling operation within the same physical boundary that is operated or controlled by the same legal organization.

Incident - An occurrence arising out of the handling of plastic resin that has an impact on the environment.

Internal inspection - An inspection conducted by the member organization's employees and not an external entity.

**OCS Core Metrics** – OCS Core Metrics consist of the number and volume or weight of any unrecovered release of plastic pellets, flakes, powders[1], or granules, within the physical custody[2] of a member company, from containment to ground or water outside member-operated facilities' physical boundary[3] and estimated to be greater than 0.5 liters or 0.5 kilograms per incident.

- [1] See Operation Clean Sweep Guidance Manual for provisions regarding plastic dust.
- [2] "Physical custody" means holding the property under physical (visible) possession.
- [3] "Physical boundary" Limit point where land owned/controlled by the person/organization is legally recognized, including point where surface water drains and sewers discharge into the public sewer or controlled waters.

**OCS Member** – An organization that handles plastic resin in a pre-production form that has formally joined an active OCS Program.

**OCS Parent Program** – The OCS program that is operated by ACC's Plastics Division and PLASTICS, which is the licensor for all international OCS Programs.

**OCS Supporter** – An organization that does not physically handle plastic resin, such as a trade association or equipment provider, but would like to support the growth of the OCS program and the goal of zero resin loss.

**Plastic resin** – A solid material which contains as an essential ingredient one or more high-molecular mass polymers and which is formed (shaped) during either manufacture of the polymer or the fabrication into a finished product by heat and/or pressure.

**Plastic resin handling operation** – An operation that handles at least one ton or 2,000 pounds of pre-production plastic resin per year and manufactures, transports, warehouses, distributes, repackages, processes, and/or converts plastic resin.

**Plastic resin handling procedures** – Procedures implemented within an OCS member facility that may include checklists for loading or unloading material, spill response, preparations for extreme weather events, and other practices focused on plastic handling activities to prevent plastic loss.

**Preproduction Plastic** – Plastic resin (meeting the above definition) in the form of pellets, flakes, granules, or powder that has not been formed into a final product.

Release - Material that is lost to the environment and is unrecoverable.

Spill - Material that may be contained or recoverable, such as spilling plastic pellets on a production floor that can be swept up.
